#### **About Fair Districts GA**

Fair Districts GA is a <u>nonpartisan</u> organization that works to end electoral map rigging in Georgia.

Our focus is to fight gerrymandering, the practice of drawing legislative district lines to favor one group over another.

Our ultimate goal is to reform Georgia's <u>process</u> for drawing state and federal electoral maps.

Georgia is now a swing state. Our legislative and congressional districts should reflect this new reality.

#### **2021 FDGA Strategy**

- Convince Georgia General Assembly to produce fair maps during decennial redistricting, avoiding another gerrymander
  - Balanced between political parties
  - Reflecting racial makeup of population
  - Responsive to shifts in voting patterns
  - Aligned with communities of interest
- 2. Improve transparency of redistricting process
- Build support in and out of the legislature for reform legislation in future cycles

An ongoing success story


#### This time last decade...

to set the stage for real reform.






#### Not Right vs. Left; Right vs. Wrong

Gerrymandering is about power, even more than partisanship.

It's petty and it's personal.

**Tell the story** - it's a gross abuse of power that should outrage every citizen.

#### **End Gerrymandering In Virginia!**

Voting districts belong to Virginians, not politicians or parties. We're pleased that the 2019 General Assembly passed a constitutional amendment to create a Virginia Redistricting Commission, but it needs to pass a second time in 2020. Please vote to pass the amendment again, so Virginia voters can vote on it directly in November 2020.

Additionally, the 2020 General Assembly should pass legislation to set criteria for the redistricting process, including:

- An open process for citizen involvement in the commissionExplicitly prohibit gerrymandering and keep communities together
- · Clear rules that keep our communities together when new districts are drawn



#### The magic formula

A legislator went from "I never hear about this so I don't have to care" in three steps.

- 1. 2000 sign-ups in their district
- 2. A competitive (prominent) election
- Insider meeting

#### A perfect political storm - 2019

Leading up to the 2019 General Assembly elections, both chambers were virtually tied, and experts predicted a Blue Wave.

First read of the constitutional amendment - "gimme" vote

For the first time, both parties were in a position to benefit from compromise.

**Villains become heroes** - competitive primaries and public pressure.

Working hard to get lucky.

#### Primed for success in 2019

National attention

Volunteer base at full force - 100,000!

Harnessing righteous anger

**Lobby Day** 

Emails/phone calls/postcards/lit drop



#### Then the tables turned

Dems took over both houses

Suddenly a lot of concern about the proposed amendment...

House of Delegates tried to prevent a vote entirely, killed enabling legislation in conference committee, but narrowly passed.



#### What we have now



Districts will be drawn by a commission comprised of 8 citizens and 8 legislators, with one of the citizens serving as chair.

#### 4 Steps to being an effective Citizen Advocate

- 1. Do your homework
- 2. Know whom to contact
- 3. Decide how to contact them
- 4. Formulate the message





#### **Step 1: Do your Homework**

#### **Democracy Act**

- SR 20/HR 55 in 21/22 session
- A resolution for constitutional amendment includes transparency, standards, independent commission
- Requires passage of "joint" resolution both houses by 2/3 majority
- Requires ratification by majority of voters on ballot of even year general election
- Effective the first of January following passage by voters



#### **Transparency Act**

- SB 186/HB 189 in 21/22 session
- Bill focused on transparency of redistricting process
- Requires passage by majority in both houses
- Requires Governor to sign or do nothing (not veto)
- Typically becomes effective first of July after passage




### **Step 2: Know whom to contact**

- Your Senator and Representative



### Step 3: Decide how to contact them

- Email
- Phone
- Post to social media





### **Step 4: Formulate the Message**

- Templates will be provided

### <u>Transparent Redistricting</u> - Email Template

Dear Representative/Senator \_\_\_\_\_\_\_,

I am writing to voice my support for a transparent redistricting process in the 2021 cycle.

As a member of the redistricting committee, I ask that you ensure transparency and establish robust guidelines for this redistricting process. Transparency requires the opportunity for public input throughout the process, reasonable time for review and comments on proposed maps, and full disclosure of all of the legislature's redistricting work.

I also ask that you support this goal by signing on as a co-sponsor to the Transparency Act [HB 189/SB186], and making sure hearings are held and this legislation comes to a vote in the [House/Senate].
