



What is the Public Service Commission?

- The mission of the Georgia Public Service Commission is to exercise its authority and influence to ensure that consumers receive **safe**, **reliable**, **and reasonably priced** telecommunications, electric and natural gas services.
- The PSC regulates the services provided by investor-owned telecommunications, natural gas, and electric utilities, and **directly regulate the rates charged by Atlanta Gas Light and Georgia Power.**
- The three most important things the commission does for **electricity** is the **Integrated Resource Plan**, where they make decisions about how Georgia Power should generate electricity; **the Rate Case**, where they decide how much Georgia Power customers should pay for it and how much profit the company should make; and the **Vogtle cost overrun hearings** where they typically pass the costs of their \$30 billion nuclear plant to customers.

Advocating before the PSC in 2019

- Hearings occur when most of the public is working, during 9-5 pm
- The room was very empty, save for intervenors, PSC staff, the commissioners themselves, and of course Georgia Power employees
- Commissioners were often disengaged during public comment, having side conversations, or poking fun, or dismissing the concerns of public commenters
- I met with a commissioner 1:1 who told me that it is very difficult to "go against the power company" and that he learned that incrementalism was the best approach. (See <u>MLK's letter from a birmingham jail</u>)
- I felt like my commissioner (Chuck Eaton) would have a similar stance.


How Public Service Commissioners are elected

- Despite the districts, commissioners are elected **statewide** during general elections. Commissioners must live in the district they run for.
- Commissioners serve 6 year terms, unless they resign, in which case the governor appoints a commissioner to serve until the next general election
- The elections are staggered, meaning they are on the ballot every two years:
 - 2022 District 2
 - 2024 District 3* & 5
 - 2026 District 1 & 4


* In August 2021 District 3 commissioner Chuck Eaton was appointed to serve as a judge in Fulton County Superior Court in the Atlanta Judicial Circuit. Fitz Johnson (R) was appointed to fill his term, which triggered a special election and District 3 is now on the November 2022 ballot.

Georgia Power Service Territory


The white areas are GA Power customers, which is the electric utility that the PSC regulates. This means that people living in these areas are directly impacted when the PSC decides to raise rates, and add charges, fees, and otherwise pass costs on to customers' power bills. Other customers served by Municipal Electric Authority, other city utilities, and Electric Membership Co-ops do not experience a direct impact on their bills.

What is Rose vs. Raffensperger?

- The complaint was filed on July 14, 2020 and alleges that the **Secretary of State** administers **Public Service Commission** elections using an at-large election method, which violates Section 2 of the Voting Rights Act of 1965.
- Plaintiffs are Richard Rose, James Woodall, Wanda Mosley, and Brionté McCorkle
- The case was tried before **Judge Grimberg** (a Trump appointee) in the United States District Court in the Northern District of Georgia Atlanta Division.
- The case so far is the only case EVER to challenge the at-large election method on a statewide race, so it is historic and precedent setting.

What is Section 2 of the Voting Rights Act?

- Section 2 prohibits voting practices or procedures that **discriminate on the basis of race**, color, or membership in one of the language minority groups identified in Section 4(f)(2) of the Act.
- Most of the cases arising under Section 2 involve challenges to **at-large election schemes**, but the section's prohibition against discrimination in voting applies nationwide to any voting standard, practice, or procedure.
- Section 2 is **permanent and has no expiration date** as do certain other provisions of the Voting Rights Act.

The best example is District 3

- Residents in District 3 are majority black, and also a large part of GA Power's customers base.
- District 3 voters consistently vote with 70%+ cohesion to vote out the R incumbent, but voters in other parts of the state keep them in office.
- The District 3 commissioner has been a white male Republican in the PSCs 100+ years of existence, the only exceptions being:
 - David Burgess (D), from 1999-2007
 - Fitz Johnson (R), appointed in 2021
- This is a clear case of vote dilution.


STATEMENT OF INTEREST OF THE UNITED STATES UNDER THE VOTING RIGHTS ACT

The United States respectfully submits this Statement of Interest pursuant to 28 U.S.C. § 517, which authorizes the Attorney General "to attend to the interests of the United States in a suit pending in a court of the United States." This case presents important questions regarding enforcement of Section 2 of the Voting Rights Act of 1965, 52 U.S.C. § 10301 ("Section 2"). Congress has vested the Attorney General with authority to enforce this provision on behalf of the United States. See 52 U.S.C. §§ 10101(c), 10308(d). Accordingly, the United States has a substantial interest in ensuring Section 2's proper interpretation.



We won!

- Oral arguments were held June 27, 2022 through July 1, 2022.
- On August 5, 2022, the eve of the anniversary of the Voting Rights Act, Judge Grimberg ruled in the plaintiffs favor, agreeing that the PSC election structure is a violation of Section 2 of the Voting Rights Act.
- The judge ordered the election to be removed from the November ballot.
- The following week, the SOS appealed the ruling on the grounds that Tricia Pridemore gave four reasons for why the PSC races had to be elected statewide, which the Judge did not include in the final decision.
- The appeals court agreed to put the race back on the ballot and allow the election of "holdover officials" until the appeal works it way through the court.
- Plaintiffs asked the Supreme Court to grant a motion to take the races back off the ballot. The Supreme Court ruled that the state's appeal was improperly filed and that it needed to be re-submitted, effectively ordering the races back off the ballot

The appeal hearing and next steps...

- On December 15, 2022, the 11th U.S. Circuit Court of Appeals heard oral arguments for the state's appeal. The decision is currently pending.
- If the ruling is upheld: State lawmakers have to come up with a new way to elect PSC members during the legislative session. The court will need to approve any proposed remedy. Then, the Secretary of State would move forward with a special election for the two PSC positions that were postponed in November.
- If the ruling is overturned: The Secretary of State will move forward with a special election for the two PSC positions that were postponed in November.

Unanswered Questions:

• When will the special election be scheduled? Will there by primaries? Is there an opportunity for new candidates to enter the race?


Enacted map – 2012



Enacted map – 2022 – SB472




House Dem Caucus proposed - 2022








Constructing the SB472 map from 2012 base








SB 472 PSC map enacted February 2022




Constructing the Dem caucus map from 2012 base











Illustration: A Three-County Solution moves only 2.4% of GA's population
