# Harms of Gerrymandering

- Non-competitive districts → lack of voter choice
- Real competition is in party primaries → farther left/right representatives
- One-party control of legislature
- No fear of losing next election
- Legislation driven by partisan ideology, not voter preferences

*Has this really happened in GA?*



# Georgia has a 150-year history of one-party control of state government


- 1872 – 2002: Democratic dominance - governor and general assembly
- 2003-4: Divided government
  - First Republican governor since Reconstruction
  - State Senate was elected as 30D-26R, but 4 Ds switched parties.
  - State House stayed Democratic (106D – 73R)
- 2005 – present: Republican trifecta
  - 12 state legislators switched to Republican party between 2005 and 2011



*2003-4 is the only period of divided government in 150 years.*




# Georgia has become a swing state after 20+ years of partisan dominance

# Georgia has a long history of uncontested races, especially for General Assembly Seats



# Uncontested races dramatically restricted voters' choices in 2020

Uncontested races  
 GA Senate: 28 = 50%  
 GA House: 94 = 52%

## 2020 Election Votes Cast



No vote cast in state house race: 449,000 fewer than President's race (9%)

40% of votes cast in uncontested races

39% of votes cast in non-competitive races

12% of votes cast in competitive (<55%) races




# What voters want for redistricting

- Fair maps
  - Reflecting political preferences
  - Not disfavoring one party
  - Reflecting racial and ethnic diversity
  - Compliance with Voting Rights Act
- Fair process
  - Transparency - "show your work"
  - Citizen involvement
  - Eliminate conflicts of interest
  - Preferred model: independent commission




# Nationwide, bi-partisan support to end gerrymandering with independent commissions

*Which of the following would you prefer to set the guidelines for drawing boundaries for legislative and congressional districts in states?*





# Georgia has been constantly gerrymandered since at least 2000

- 2001 – Democrats
  - Enacted by party line vote
  - Packed Republican districts, maximized Democratic districts
  - Overturned by Supreme Court in 2004
- 2005 – 2021 – Republicans
  - 2011/12
    - Achieved super-majority in Senate, near-super in House despite declining vote share
  - 2021
    - Locked in Republican majorities in all 3 maps despite <50% vote share
    - Disadvantaged minority voters; 5 Federal lawsuits pending
  - Mid-cycle redistricting – 64 districts changed

	54% (32%R – 76% D) oppose campus carry (AJC Jan 2017)	Campus carry (2017)
Allow concealed carry without permit	70% (54%R – 86%D) oppose (AJC Jan 2022)	“Constitutional carry” (2022)

# Gun rights votes in general assembly

“Constitutional carry” (2022)	State House (91 votes to pass)	State Senate (29 votes to pass)
2020 election result	103R – 77D	34R – 22D
Votes FOR	100 (100R – 0D)	34 (34R – 0D)
Votes AGAINST	67 (0R - 67D)	22 (0R - 22D)
Not voting / excused	12 (2R - 10D)	0
Win margin	10	4
Estimated map bias	+1-8 R	+1-4 R

***“I’ll tell you what my wife always tells me. They haven’t called me yet to ask my opinion.”*** – prominent GA politician responding to reporter’s question about polls not supporting this bill.

# Medicaid expansion - Background

- 2010 Affordable Care Act covers 90-100% of cost to states to expand Medicaid up to 138% federal poverty level
- Georgia is 1 of 12 states that have not expanded
- Pros:
  - 470,000 Georgians gain health insurance
  - \$3B / year federal taxes returned to Georgia
  - 56,000 health care jobs created
- Cons:
  - \$140M / year net cost to Georgia
  - Federal government debt risks federal share

2017	75% in favor (92%D – 57%R – 74%I)	
2019	71% in favor (96%D – 40%R – 72%I)	SB 106 – Partial expansion proposal w. work requirements, requests 90% federal funds

Win margin	14	4
Estimated map bias	+1-8 R	+1-4 R

## Recent events

- Fall 2019: Proposal released for public comment - 90% oppose, 4% favor
- October 2020: Federal HHS approves (Trump admin)
- December 2021: Federal HHS cancels approval (Biden admin)
- January 2022: Kemp admin sues Federal HHS

# Notable bipartisan healthcare achievements

- 2020: Medicaid post-partum care extended from 60 days to 6 months:
  - House: 144-0 (36 NV)
  - Senate: 44-0 (8 NV)
- 2022: Medicaid post-partum care extended to 1 year
  - House: 142-18 (20 NV)
  - Senate: 56-0
- 2022: Mental Health Parity Act
  - House: 166-0 (14 NV)
  - Senate: 56-0

# Georgia's Living Infants Fairness and Equity (LIFE) Act aka "Heartbeat bill"

- Passed in 2019
- Bans abortion after fetal heartbeat activity (~6 weeks)
- Exceptions
  - Rape or incest if reported to police
  - Woman's life in danger
  - Medical futility – fetus not viable
- Establishes personhood rights for unborn at ~6 weeks
- Struck down in court 2020
- Reinstated July 2022 after Dobbs decision

Win margin	2	6
Estimated map bias	+1-8 R	+1-4 R

# Reproductive rights – How do voters feel now?

Time frame	Question	Voter preference – July 2022 AJC poll
July 2022	Overturn Roe v. Wade?	Support 39% (7.6%D, 71.3%R, 29.5%I) Oppose 54% (89.8%D, 21.4%R, 60.3%I)
	Support GA LIFE Act?	Support 36% (9.1%D, 64%R, 26.6%I) Oppose 54% (84.9%D, 25.9%R, 62.1%I)

Meanwhile, back in Kansas....

- Voters reject change to constitution removing protection for abortion rights 59%-41%
- Stops gerrymandered legislature from enacting limitations
- Huge turnout, bipartisan vote across red and blue counties

- Publicize within FDGA non-partisan guidelines

# 2022 Georgia Candidate Pledge

I pledge to support fair redistricting and redistricting reform across Georgia to include:

- A fully transparent redistricting process with robust citizen engagement
- Fair district maps, validated by independent experts, that reflect the diversity and communities of interest of Georgia and do not unnaturally favor any political party
- Competitive districts that give voters meaningful candidate choices
- An end to mid-cycle redistricting and prison gerrymandering
